

TERMS AND CONDITIONS 1.0

When creating an account and or accessing the mobile application (the "Service"), you agree to be bound by these terms of use ("Terms of Use"). The Service is controlled by Celebrity-App ("Celebrity-App"). These Terms of Use affect your legal rights and obligations.
